Recording data for the Declaration of Covenants, Conditions and Restriction of Greenbrier was incorrectly stated.

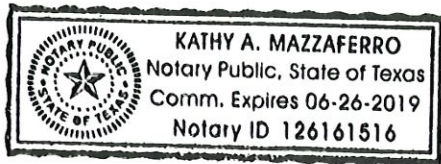
